Terms and Conditions

NO PURCHASE NECESSARY TO ENTER OR WIN

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry and claim instructions are deemed to form part of the Terms and Conditions and by participating in the Prize Draw you will be deemed to have read and accepted all of the Terms and Conditions. How to enter

- 5. You must log onto <u>www.lyceum.org.uk</u> (referred to herein as "web site") and follow the directions to enter.
- 6. You must include on the entry form your complete name and email address. All entrants must have a valid email address to enter. In case of dispute as to the identity of the entrant, the entry will be declared made by the authorised account holder of the email address submitted at time of entry. Draw
